Highway Report — (Mike Fuller) —For the month of February, the state roads were plowed 30 times and salted 34 times and the town and county roads were plowed 24 times and salted 21 times. Pot holes were filled, trees were trimmed and cut, meter pits were read and checked chlorine ppm's in the water lines. Mike attended Advocacy Day (local roads matter companies) in Albany for Highway Superintendents where they asked for a \$150,000,000 increase in CHIPS funding and to restore EWR money in the amount of \$65 million.

Assessor Report – (Trisha Laszewski) – Cleaning up from the exemption season. There were 358 mandatory IVP's (Income Verification Program) faxed to NYS Tax and Finance. 1100 exemptions with Shelby having 40%, Ridgeway 35% and Yates 25%.

<u>Planning Board Report</u> — (Kirk Myhill) — Had to sign requests. One was for Zambito Realty and that was approved after taking recommendations from the ZBA and the second was for Welker Farms and that one was also approved.

Zoning Board Report – (Dan Wolfe) – In February, ten (10) inspections were completed, two (2) building permits were issued and two (2) Maintenance violations were issued. Attended the ZBA, Planning Board and County Planning Board meetings, logged 72 hours and 169 miles.

Ken asked if Aldi's had begun work on the expansion project and Dan informed him that they have just begun and they'll be closing April 7th until mid May to complete the interior.
