Call to Order: Chairman Craig Lacy called the Public Hearing to order at 6:20 pm

Chairman Lacy opened the Public Hearing and request to Secretary P Bushover for a roll call all members were present and the ZBA had a quorum. Chairman Lacy requested Secretary P. Bushover to read the Legal Notice (see Att. 1) published March 28, 2021 in the *Lake Country Pennysaver*. Secretary reported that there were no letters received regarding this application.

Chairman Lacy ask the applicants to explain the operation of the proposed Ag Processing Facility (slaughter house). The Kepplers explain that the building has the kill, processing, and clean up under one roof, there will be only a one day as a kill day, no animals stored onsite, animals will be under cover, all animal waste will be refrigerated and pick up the day of slaughter all procures are regulated by USDA. a retail business selling the processed meat will operate in the front area of the building. The Kepplers stated that there will be landscaping by the road.

Dan Wolfe CEO explained that this Public hearing was for the area variance and the application will be going to the County Planning Board for review.

Chairman Lacy call for question from the public for any comments or questions.

Andrew Szatkowski asked what the County Planning Board would do. D. Wolfe explained that the county would review the proposed operation site plans and send their comments to the town Planning Board.

George Skinner expressed his concern about the lighting, view and noise would effect his mother's property to the north. The Kepplers explained that there is no night lighting and there will be landscaping in that area. He also asked about the Ag/Residential district regulation D. Wolfe explained that Ag Processing is allowed by the Town's Zoning Code. Mr. Skinner wanted to know why this location. The Kepplers explained that this location had the 3 phase power, water and natural gas that is needed for this operation. Mr. Skinner said that his family voted no for this project.

Amy Watts expressed her concerned about the safety of the driveway because of the curve in the road. The Kepplers explained that the traffic in an out will not be that great.

Chairman Lacy called for more comments from the public hearing none.

Chairman Lacy asked the ZBA members if they had any question hearing none.

Chairman Lacy stated that the ZBA will table findings on the requested variance until the County Planning Board action on April 22, 2021. Action on this variance will be taken at the next ZBA Business Meeting.
