Supervisor Smith announced there was one addition regarding authorizing payment of \$2650.00 to Matt CM Contracting Inc. to secure fire damaged property and to waive procurement policy due to energy need to protect public safety.

<u>Highway Report</u>: (Dale Root) We were able to help out Ridgeway, Barre, Clarendon, Yates and the county with their projects as they will be coming to Shelby next week to

assist with the sealing projects at Fletcher Chapel, Ryan, and Martin. Be advised that these roads will be blocked during the day on August 15. Tomorrow (Aug 10) the town building will be shut down for National Grid to make electrical repairs caused from the fire in the building last December. Some burials and cemetery stone foundation pour's have been done and will be billed out soon. Roadside mowing continues and mowing the parks and fire halls are done weekly. Replaces a leaking fire hydrant on East Shelby Road. Ordered and received 1250 ton of salt for inventory. He is sad to report that one of his MEO's mother passed away last month and would like to say thank you to the board for the flowers sent. He is sure the family appreciated them. The Highway Dept. pulled together also with a floral tribute, Thank you to the men in his department. Never ending stacking of e-waste continues.

<u>Assessor's Report</u>: (Trisha Laszewski) Not too much to report this month. She hasn't heard where tax bills will be collected this year. Property owners are still looking for their tax rebate checks.

<u>Planning Board Report</u>: (Kirk Myhill) The Planning Board got the recommendation from the county for the site plan review for the wind project on South Gravel Road. The Planning Board reviewed those and went over the plans and made a recommendation and I believe each Town Board member should have a copy of the recommendations which is approval with some other stipulations along with it. He also informed the planning board members that the county has put more training on their website. If they want to do any additional training that they can go there and get more training.

Zoning Board Report: (Dan Wolfe) The structure at 5063 South Gravel Road has been demolished. It looks good. Special thanks to Art Hill construction. He wants to personally thank the town board for all of their hard work and wants to thank Bethany for her legal work. The result is really amazing. He issued seven building permits in July. So far this month he has spent about half of his time on inspections and the other time in the office making himself available for the public. He worked with the ZBA on three area variances in the last month and a half and one came in today. He thanked Candy for coming in and processing those. She is an excellent processor of variances and so she was in today working for a few hours.
